## Golden Card of the Workplace Safety Leader for Polimex Mostostal Capital Group

The Golden Card of the Workplace Safety Leader can be granted to a member of the Forum who has already been awarded a Silver Card and who has actively cooperated with the Institute for at least five years. In order to obtain the award a company needs to maintain the rate of workplace accidents and occupational illnesses below the national average, as well as implement an efficient OHS management system. Last but not least, the commission awarding the Golden Cards evaluates the company's strategic prevention activity for promoting the culture of safety and its investments in the occupational health and safety within the company's operations.

After a positive verification of an application for the Card by the Commission for the Selection of the Workplace Safety Leaders, the awarded company receives a certificate which is valid for two years from the date of its granting. The certificate entitles the enterprise, inter alia, to seek the Institute's support in terms of promoting scientific research aimed at improving occupational health and  $\leq$  in Poland and abroad.
