

# **The Supervisory Board of Polimex-Mostostal appointed the President and Vice President of the Management Board**

On April 23, 2013 the Supervisory Board of Polimex-Mostostal appointed Mr. Gregor Sobisch as the President of the Management Board.

In addition, on April 24, 2013 the Supervisory Board of Polimex-Mostostal appointed Mrs. Joanna Makowiecka to the Management Board and entrusted her the function of the Vice President.

The new President and the new Vice President will take obligations on 3 June 2013.

The Supervisory Board made the choice as the result of the conducted interviews.

Board and the Chairman of the Management Board.

He is a member of the Polish Association of Construction Industry Employers and the Association of Stock Exchange Issuers.
