STRATEGIC PROJECTS

Polimex Mostostal Group carries out various projects of strategic importance for the Polish economy and energy security of the country.

Thanks to the use of the most innovative technologies, the power units that we build meet and exceed the strictest EU environmental standards. Currently, we carry out the following projects:

Kozienice



Unit B11 in the Kozienice power plant that belongs to Enea Wytwarzanie is the most modern coal-fired power plant in Europe, with electricity output of 1075 Megawatts. For the first time the electricity from the new unit fed the national grid at the beginning of September 2017. On 19 December 2017 an official ribbon-cutting ceremony of one of the most important investment projects on the Polish energy market has taken place.

The value of the consortium agreement between Polimex-Mostostal and Mitsubishi Hitachi Power Systems Europe for the construction of the unit in Kozienice amounts to PLN 5.1 billion net. Polimex Mostostal's scope of works includes construction and erection works, and commissioning of all Balance of Plant systems, the share of which in the contract price amounts to 42.6 percent, which is PLN 2.17 billion.

Opole



Construction of Units 5 and 6 in the Opole power plant that belongs to the PGE Group is the largest energy investment after the change of political system (1989) in Poland.

Construction works on a coal-fired power plant units with a total capacity of 1 800 MWe began in February 2014. Its value is PLN 11.5 billion gross, of which some 42%, or 4.83 billion, is for Polimex-Mostostal.

The units for PGE GiEK in Opole are executed by the Consortium of: Polimex-Mostostal, Mostostal Warszawa and Rafako (the scope subcontracted in its entirety to GE Power).

Polimex-Mostostal's scope provides for the delivery and erection of turbine islands, cooling water with 185-meter tall cooling towers, complete electrical and I & C works, roads and rail tracks as well as external BOP systems.

Gross power of each of the units is 900 MWe

Żerań



The construction of a gas and steam unit for the Żerań heat and power plant that belongs to PGNiG TERMIKA is a strategic energy industry investment for the Warsaw metropolitan area.

The consortium agreement among Polimex-Mostostal SA, Mitsubishi Hitachi Power Systems Europe GmbH, Mitsubishi Hitachi Power Systems Ltd. and, Mitsubishi Hitachi Power Systems Europe Ltd., covers delivery and erection of a Combined Cycle Gas and Steam Unit at Elektrociepłownia Żerań, with electricity output of 490 MWe net and maximum thermal power of 326 MWt, along with Balance of Plant systems and installations.

Gross electrical power output of the unit is 490 MWe
